Silos and Silence No More: BCFNJC Releases What We Heard Report from its 2023 First Nations Justice Forum

Report Captures Key Insights and Priorities from Rightsholders on Transforming the Justice System and Advancing the BC First Nations Justice Strategy

(Okanagan Syilx Territory, Westbank BC): The BC First Nations Justice Council (BCFNJC) is pleased to release the *What We Heard Report* from the second annual First Nations Provincial Justice Forum (Justice Forum) that was held on March 6-8, 2023. The 2023 Justice Forum brought together First Nations leaders and representatives from across BC to discuss their shared vision for restored justice and the implementation of the BC First Nations Justice Strategy (the Strategy).

BCFNJC is currently leading the implementation of the Strategy, which is comprised of 25 individual strategies and 43 lines of actions designed to reform the current justice system and restore Indigenous legal orders, traditions, and structures. At the 2023 Justice Forum, Rightsholders were updated on the Strategy's progress and were able to share their insights on the Strategy's key components and initiatives, including on Indigenous Justice Centres, Gladue services, justice for Indigenous women and girls, a National Indigenous Justice Strategy, and much more.

Overwhelmingly, a charged sense of purpose and commitment was felt and expressed by attendees– a desire to reclaim legal space and break down the discriminatory and oppressive silos that colonialization has built up. We heard from Rightsholders about the need for Indigenous inclusion and representation at every point in the justice system, as well as holistic approaches to justice that account for cultural programming and the roles of Elders, Knowledge Keepers, and Matriarchs. Alternative pathways of restoration and medicine need to replace rigid and punitive justice processes. As keynote speaker, Honourable Jody Wilson-Raybould (Puglaas), concluded: "Transforming the justice system is the work of bringing down the silos between traditions, teachings, and experiences."

As BCFNJC continues to work with First Nations across the province to remove these silos, the lessons and themes captured in the *What We Hear*

Report will inform and support the implementation of the Strategy and its tangible outcomes at the community and Nation level. BCFNJC is excited to hold the next annual First Nations Provincial Justice Forum on April 8-10th 2024 in downtown, Vancouver on the traditional lands of the Musqueam, the Squamish and the Tsleil-Waututh First Nations.
